## Weingarten Rights

#### The Right to Union Representation During an Investigatory Hearing

- **1** Union members have a right to union representation at an investigatory hearing if they reasonably believe that the investigation could lead to disciplinary action.
- 2 The member must request a representative; the employer has no obligation to inform the employee of this right.
- **3** Management does not have to call the representative. Instead, the employer can stop the meeting, or just issue discipline.
- 4 Once a union representative is called, he/she has the following rights:
- To know the subject of the investigatory hearing
- To confer with the member prior to the hearing
- To speak/participate in the hearing

But the representative cannot argue the case. This is not a grievance hearing.

#### Weingarten Summary:

#### Representation must be requested.

• Silence can be an effective waiver.

• There is no voluntary waiver of the right when the employee is threatened with a harsher penalty if the matter goes to a higher level.

• The employee does not have to remain adamant in their request for union representation.

• The employee may not leave the interview and seek out a union representative in violation of their supervisor's orders and established policy.

• A specific union representative need not be provided if he/she is unavailable due to personal or other reasons for which the employer is not responsible.

• The employee may consult with their representative before an investigatory meeting, and either the employee or the representative may request a pre-investigatory conference.

## Important Dues Information

## As a union member who is on payroll dues deduction for your monthly union dues, you need to know the following:

If you are on *Worker's Compensation Leave, Disability Leave, Maternity Leave,* etc... then you are no longer on the payroll and monthly union dues are not being deducted and remitted. Therefore, you are responsible for sending in your minimum monthly union dues of \$15.00 to the Federation (1700 N.W. 66th Avenue; Suite 100; Plantation, Florida 33313) in order to maintain your active member status with the union. If you do not send in the minimum dues requirement, then you may be dropped from the union membership and lose the free Life Insurance that the Federation provides.

When you return to work, check your pay stub for union dues deductions. If your union dues deduction has not been reinstated, please contact the Federation and your payroll department immediately.



#### **BROWARD SHERIFF'S OFFICE**

Four Court Deputies working at the Central Court House completed the certification process for Court Training Officer and were designated to train new employees. The Court Deputies functioned in the capacity of Court Training Officer for a year, but were not compensated for the additional assignment. The Federation was successful in addressing the situation and the four Court Deputies were awarded one year retro active training pay. -Lisa Zarazinski

A Data Entry Clerk was assigned the task of training and evaluating employees on a software program that was expanding throughout the agency. The assignment also required the employee to develop training materials, a training manual and to program the software specific to the need of each division. Prior to filing a formal grievance, the Federation argued that the employee was working out of classification and performing duties above and beyond their job requirement. The employee was re-classified to an Administrative Specialist I, elevating the employee two pay grades. The employee was also awarded approximately 10 months of retro active pay for the time they were working out of classification.

A Court Deputy was reprimanded for excessive tardiness and received a 3day suspension. At the Administrative Appeals Board it was argued that the employee's rights were violated in the due process of the investigation. It was also proven that management's decision to change the employees work hours contributed to the promptness issues. The 3-day suspension was reduced to a written reprimand.

A Communications Operator was reprimanded with a 1-day suspension and charged with "Appearing to sleep on duty". The Federation appealed the discipline through the Administrative Appeals Board (AAB). It was proven that no evidence within the investigative report confirmed that the employee was sleeping. The case was not sustained and the discipline was thrown out. -Lisa Zarazinski

Two employees working in the Property Unit were given counseling reports for utilizing sick leave that was approved under FMLA. Both employees properly filled out FMLA paperwork and the FMLA leave was granted by the Human Resources Department. Management tried to document that the employees were abusing the BSO Sick Leave Policy by using the FMLA time in conjunction with other approved time or their regular days off. Although Counseling Reports are not considered a form of discipline, the Federation argued the documents were inappropriate and violated the employee's rights under the Federal FMLA Act. The violations were addressed with the Federations Labor Attorneys for further review and potential legal action. Subsequently, management rescinded the counseling reports. -Lisa Zarazinski

A district CSA was requested to attend a closed door meeting with their Sergeant and Lieutenant. Upon entering the office the CSA asked if the meeting could lead to discipline. The CSA was suspicious of the meeting because of the attendees and location. When the CSA posed the question regarding discipline to management they became very angry and yelled, berated and threatened the CSA with discipline. Calmly, the CSA asked the question again, "Can this meeting lead to discipline", which further infuriated management. The question was never directly answered. The CSA remained in attendance to learn that management intended to take extra duties away from him as a measure of punishment, threatened him with discipline and an Internal Affairs Investigation. At that point, the CSA voiced that his rights had been violated and he would no longer engage in the meeting. The CSA exited the office with management following him down the hallway further threatening him with discipline.

The Federation immediately contacted the upper command within the district and scheduled a meeting. The Federation argued that the employees "Weingarten Rights" were violated and an Unfair labor Practice (ULP) would be filed against the agency if they chose to proceed with any action.

The incident was resolved, to the CSA's satisfaction, with no action taken against the CSA. All of the CSA's extra duties were reinstated and no investigation or disciplinary action was imposed. -Lisa Zarazinski

#### **CITY OF OAKLAND PARK**

Employee was terminated for stealing time off the job. Attendant filing a grievance. The employees termination was reduced to suspension. -Guv Masters

#### FACILITIES SERVICE DIVISION

Peter Rooney a Facilities Serviceperson at Marjorie Stoneman Douglas High School working out of class for a year and one-half. A grievance was filed. Mr. Rooney was awarded on his behalf approximately \$8,000.00 in back pay.

A Class Action grievance to correct the improper use of Facilities Service Aides who were working out of class is slowly being resolved by the School Board throughout the District one school at a time to award these aids to be promoted to a full Facilities Servicepersons position.

A Class Action grievance was filed against the Broward County School Board for not following the Collective Bargaining Agreement language on District seniority during layoffs. A settlement offer has been extended. If this is not agreeable with the Federation, it will be taken to arbitration.

Also, numerous Memorandums of Understanding have been filed, settled and agreed upon for payment on promotions and working out of class for the Facilities Serviceperson. All of which totals into ten of thousands of dollars. -Rov Jarrett

## **Obama Leading in Polls as Nation Readies for Election**

**P**residential contender Barack Obama was climbing in the polls in late September as his plans to restore the economy and rebuild the middle class appeared to be taking hold with more and more voters.

His message was having all the more impact as Congress struggled with trying to make sense out of—and make fair to the taxpayers, if possible—the Bush Administration's hurried plan for a \$700 billion bailout of the disgraced financial services industry.

The labor movement was working full-tilt on behalf of the Illinois Senator, pouring tens of thousands of volunteers and millions of dollars into the election, especially in a handful of up-for-grabs states where Obama and Republican candidate John McCain were seen as in a virtual dead heat.


Nearly every union had endorsed Obama, a Harvard law school graduate who became a community organizer in Chicago and who established strong ties with the city's labor movement while moving up through the state legislature and into the U.S. Senate.

By late September, national polling showed Obama leading Mc-Cain by a margin in the range of 9

to 11 percent. More Americans appeared to be trusting Obama than McCain to deal with the nation's financial woes.

Hurting McCain was his long history of opposing regulation of the stock market and financial institutions generally. It was a failure to control the financial industry that led the nation to what many believe is the brink of a major recession, if not a Depression.

McCain's selection of Alaska Gov. Sarah Palin as his vice presidential running mate, which fascinated the nation early on, was wearing thin. The novelty of a clever and attractive female running mate was quickly giving way to concern over Palin's total lack of international experience and limited domestic leadership. She had served a few years as mayor of a town of 6,000 and less than two years as leader of a state with a total population less than that of Memphis, Tenn.

While McCain's plans for job

creation are centered on maintaining tax breaks for corporations and wealthy Americans, which he believes would free up capital that would be used to expand the economy, Obama offers more explicit and direct tactics.

The Democrat is calling for a new economic stimulus—\$50 billion that would create one million jobs through projects to rebuild roads, bridges and other infrastructure, repair schools and help states and cities avoid cutting damaging budget cuts that would reduce vital services to working families.

For the long term, he would "revive and strengthen American manufacturing" with a \$150 billion 10-year program in the green energy sector that could create as many as 5 million jobs. He also calls for a new Advanced Manufacturing Fund that would focus on innovation and job creation in areas hit the hardest by the decline of manufacturing.




